- (iv) the Aggregate Notional Amount of the Certificates effectively placed is equal to Euro 2,140,000, represented by no. 122 Certificates having each a Notional Amount per Security of Euro 20,000. The Aggregate Notional Amount issued is equal to Euro 2,440,000.
